Purpose

The purpose of this course is to explain the pathophysiology of abusive head trauma and outline common injuries, assessment and treatment options, and injuries typical of accidental injuries.

Goals

- Discuss indications for decompressive craniectomy.
- Discuss the Glasgow coma scale, including scoring.
- Discuss injuries consistent with accidents related to various types of falls.

### Introduction

People rarely admit to abusing infants and children. Instead, they invent "accidents," such as the child's falling out of a crib or highchair, falling down the stairs, or being hit by other children. Unless head injuries are probable, such as with an unconscious child, healthcare providers may overlook signs and symptoms of abusive head injury.

However, there are patterns of injuries that are suggestive of child abuse, and the healthcare provider should be aware of the difference between typical injuries associated with accidents and those associated with abuse.

The term "shaken baby syndrome" has been commonly used to describe brain injury symptoms consistent with a person vigorously shaking an infant or small child. The injuries most consistent with shaken baby syndrome include unilateral or bilateral subdural hemorrhage, bilateral retinal hemorrhages, and diffuse brain injury.

However, while children can be injured by shaking alone, authorities often find injuries that exceed those just from shaking and include evidence of blunt trauma, so a more inclusive term, "shaken impact syndrome" is frequently used. An even broader term, "abusive head trauma," includes not only injuries associated with shaking and direct blunt trauma but also with dropping or throwing a child.

"Abusive head trauma" is now the term recommended by the American Academy of Pediatrics. Because this term describes the type of injury rather than the mechanism of injury (such as shaking), the use of "abusive head injury" may have legal significance as the specific means of injury can rarely be ascertained, so indicating a child has

"shaken baby syndrome" may preclude evidence of other types of injuries and allow for more challenge in court.

Most victims of abusive head trauma are less than a year old, typically between 3 and 8 months, but these characteristic injuries can occur in children up to 5 years of age or older. In most cases, the perpetrator is a parent or caregiver, with 65% to 90% being male, usually the father or mother's boyfriend. The National Center for Shaken Baby Syndrome (also now using the term abusive head injury) estimates that approximately 1200 to 1400 children each year are injured or killed by abusive head injuries in the United States.

Abusive head trauma is the leading cause of death and disability in infants and young children, resulting from child abuse. Child abuse has been identified as the cause of brain injuries in 24% of children <2 and suspected as the cause in an additional 32%.

### **Traumatic injury**



The infant and young child are more susceptible to head injury than older children or adults because of a combination of factors:

- The head is large in proportion to the rest of the body, so children tend to land headfirst when they fall.
- The child's brain has a higher water content (88%) than adults (77%), so the brain is softer and more likely to experience injury from acceleration-deceleration injuries.
- The head and neck are unstable with support more from ligamentous structures than bony structures.
- The unmyelinated brain is more likely to have shear injuries.
- The skull is easily deformed and presses in on brain tissue when impacted with most injuries coup rather than contrecoup (as is common in adults).
- Axons are disrupted because of shearing of long white matter tracts with acceleration-deceleration injuries, leading to cell death.

When a child is shaken, struck in the head, or thrown against a wall, the child suffers not only the primary injuries (hemorrhage, skull fracture, contusion), but also a number of secondary injuries:

- Inflammatory biomolecular changes lead to interruptions in the microcirculation of the brain and disintegration of neurons.
- Pathophysiological changes caused by the primary injury result in increased ICP, hyperemia, and ischemia.
- Cerebral blood flow is impacted because of increased ICP.
- Autoregulation of cerebral blood flow is impaired.

#### **Retinal hemorrhage**

Retinal hemorrhage is one of the cardinal signs of abusive head trauma. Numerous studies have been conducted to examine the

relationship between various types of head trauma and retinal hemorrhage. These studies clearly show that retinal hemorrhage is most common in infants and children who have suffered abusive head trauma and should trigger further examination of the child for other types of injuries.

One retrospective study of 811 pediatric patients with traumatic injury found that 27 had retinal hemorrhages with 22 believed associated with abuse, 1 with a motor vehicle accident, and 4 with falls. Another study of 100 children <24 months with head injuries found 10 cases of retinal hemorrhage with 9 associated with probable abusive head trauma and 1 associated with motor vehicle accident. Study after study supports basically the same type of findings. Additionally, bilateral hemorrhages are associated with higher morbidity.

While retinal hemorrhage can occur without abusive head trauma, retinal hemorrhage is uncommon. However, the healthcare provider must always consider other possibilities. Other causes of retinal hemorrhage include:

- **Birth trauma:** Retinal hemorrhage occurs in about a third of neonates but usually resolves within 2 weeks. The lowest incidence is with Caesarean.
- Motor vehicle accident: The degree of head trauma may be similar to abusive head injury, resulting in retinal hemorrhage, but some studies were completed before universal use of

- restraints for children and placing of children in the back seat, so current incidence is less clear.
- **Fall:** Most falls do not cause retinal hemorrhages, but this depends on the age, height of fall, site of impact, and other factors.
- **Drowning:** Retinal hemorrhages are sometimes found in drowning victims.
- **Disease:** Retinal hemorrhage has been found with various conditions, such as disseminated intravascular coagulopathy (DIC) and AVM.

### Scalp injury/ laceration

Lacerations commonly occur in abusive head trauma, and—especially in small infants—the bleeding associated with the injury to the scalp may pose a risk of hypovolemia. The area under a scalp injury

must be examined carefully as underlying injuries, such as skull fracture or cerebral extrusion, may be present.

### **Cerebral contusion**

With direct impact to the head, bruising and tearing of brain tissue can occur, especially in the temporal and frontal areas. Bruising and

tearing of structures and vessels can occur throughout the brain, disrupting function. Contusions are generally localized and macroscopic. Symptoms can include deterioration of neurological status secondary to cerebral edema, infarcts, or developing hematomas.

**Acceleration-deceleration** injuries occur when a blow to the head causes the skull to change shape and push against the brain, causing to move sharply backward, striking the opposite side of the skull. Bruising may result from the point of impact (coup), the most common in children, or the opposite side (contrecoup). In some cases, blood may pool in areas and result in pressure and distortion on the brain.

#### Concussion

Concussion is the most frequent head injury and may result in temporary impairment of function and cerebral blood flow but does not result in structural abnormalities and outcome is generally good. Concussion is more widespread than contusion. Pooling of blood is not characteristic, and


bleeding is more likely to be microscopic. However, a child may have BOTH a concussion as well as contusions.

Symptoms of concussion include changes in level of consciousness, loss of muscle tone, reflexes, pupillary abnormalities, cortical blindness, heart rate abnormalities, nausea, vomiting, lethargy, slurred speech, and confusion.

Secondary seizures are more common in infants and young children, often associated with delayed somnolence and vomiting, while older children are more prone to posttraumatic amnesia. Older children also commonly have variations in mental status with alterations coming and going.

**Skull fractures** Skull fractures may or not be present with abusive head trauma. Studies show that skull fractures occur in about 5-15% of children with mild head injuries but in 30-70% of head injuries associated with child abuse. Most skull fractures in children are linear and diastatic (separated) so they are clearly seen on radiograph. Skull fractures often occur with lacerations. Any evidence of CSF warrants further exploration for damage to the dura. Depressed fractures may cause dural or cortical lacerations.

Basal skull fractures result from a blow to the back of the head (occurring in up to 14% of children with head trauma). Signs include:





Ocular nerve entrapment and CSH drainage from the nose or ear may also occur. Symptoms include extended nausea, vomiting, and general malaise.


Another type of skull fracture that may occur with severe injuries to infants, usually <12 months, is the cranial burst skull fracture. This fracture is a closed diastatic skull fracture with cerebral extrusion under the scalp. It is characterized by severe swelling of the scalp in the area of extrusion.

### Subarachnoid hemorrhage

SAH is the most common type of hemorrhage associated with head trauma, occurring when small vessels

in the cerebral cortex are disrupted, with the hemorrhage most often occurring along the falx cerebri or tentorium and the outer cortical surface. Symptoms typically include restlessness, nausea, vomiting, headache, fever, and nuchal rigidity.





### **Epidural hematoma**

Epidural hematoma occurs if an artery or vein is lacerated. The size of the hematoma associated with arterial laceration usually peaks at 6-8 hours and those associated with venous laceration at ≥24 hours.



In some cases, a skull fracture may overlay the hematoma, most commonly occurring in the temporal, frontal, or occipital lobes. The classic periods of lucidity between initial loss of consciousness and neurological deterioration, common in adults, is less likely to occur in children. Symptoms can include loss of consciousness, hemiparesis, pupillary changes, and posturing.

### **Subdural hematoma**

Subdural hematoma may occur as a result of birth trauma but is also common with shaken baby syndrome when the veins that

bridge the dura are torn or acceleration-deceleration forces tear cortical arteries. If related to birth trauma, symptoms (seizures, tense


fontanel, anisocoria, and respiratory distress) usually occur within 12 hours.

If related to shaken baby syndrome, the child usually has sudden onset of seizures, increasing head circumference, poor feeding, and tense fontanel without focal neurological deficits.

# Intraventricular hemorrhage

IVH is usually associated with mild head injury and resolves spontaneously, but in some cases if bleeding is more severe, a large clot may form, resulting in impaired drainage and hydrocephalus.

In this case, surgical intervention may be necessary.



### **Seizures**

Seizures are associated with increased cerebral blood flow and increased ICP, regardless of the initial injury. About 20% of those with cerebral contusions develop

seizures.

## Diffuse axonal injury

Diffuse axonal injury usually begins with axonal swelling that causes disruptions in function. This injury usually relates to

acceleration-deceleration forces. Children are up to 5 times more likely to suffer from diffuse cerebral swelling than adults, and this can lead to interference with autoregulation in about 40% of cases.

Children with diffuse axonal injury often present with varying degrees of altered mentation and may be in a vegetative state for long periods of time. Despite obvious morbidity, CT may not show injury. Prognosis with this type of injury is very poor and most children who survive will exhibit neurological impairment.

### **Assessment and treatment options**

One of the problems with providing treatment to children who suffer from abusive head injury is that often only those with severe injuries that result in death or coma are brought to the attention of healthcare providers because abusers want to hide children's injuries. Thus, many undiagnosed abused children suffer long-term effects, such as learning disabilities or hearing or vision impairment.

A wide range of treatment options are available for those children brought to healthcare providers for care, depending on the severity of injury, levels of ICP, and response to initial interventions.

Initial emergency treatment

As with most emergency interventions, the first step is to ensure ABCDEs (airway, breathing, circulation, dysfunction/disability, and external exam.

ABCDEs			
Airway	Examine the airway for obstructions, such as loose teeth, foreign bodies. Lacerations and bone instability may be obstructive. Examine the trachea for deviation and observe for signs of circumoral cyanosis (sign of hypoxia). Auscultate the airway and listen for turbulence.

### Other actions include:

examination

- Stabilize cervical spine to prevent further injury.
- Administer O2 at 100%--goal is to achieve normocarbia levels.
- Use rapid sequence induction and intubate.
- Aggressively treat hypotension as the death rate double in the presence of hypotension.
- Correct fluid losses with intravenous fluids.
- Maintain hemoglobin at >10 mg/mL and hematocrit at >30%.

#### CT scan

While CBC, UA, blood gases, and various other tests may be ordered during assessment of abusive head injury, the gold standard for diagnosis of recent injury is the CT scan. It is less expensive and less time-consuming than MRI. CT scan is usually not advised for GSC of 14 or 15 unless indicated by changes in condition during observation. However, when abusive head injury is suspected,

CTs are usually taken because the caregiver's history of injury may not be reliable.

While CT scans are relatively safe, they do pose a risk of future malignancy because children are more susceptible to ionizing radiation than adults, especially with repeated CTs, so unnecessary CTs should be avoided. A recent study indicates that a period of observation for those with mild to moderate head trauma cuts use of CT by approximately 50%.

# Intracranial Pressure monitoring

Intracranial pressure is that within the skull, in the tissue of the brain and cerebrospinal fluid. An increase in intracranial pressure occurs secondary to

other injuries. Symptoms of increased intracranial pressure in infants and children include:

- **Infants**: Fontanels bulge and normal pulsations absent, scalp veins distend, and head circumference increases. Poor feeding is common and infants may appear irritable and cry in a high-pitched tone.
- Children: Symptoms are more typical with headache, vomiting (but without nausea), diplopia, blurred vision, and seizures. Children may exhibit behavioral and personality changes with increased lethargy, inability to follow directions, and evidence of amnesia and/or memory loss.
- Late signs: Further decrease in level of consciousness, motor response, and response to painful stimuli. Pupillary changes occur, and posturing (decerebrate or decorticate), respiratory depression with Cheyne-Stokes and papilledema. Cushing's triad may be evident:
  - Increased systolic pressure associated with widened pulse pressure.
  - Bradycardia.
  - Decreased respirations.


Adequate ICP is essential in order to maintain cerebral perfusion pressure and prevent ischemia and avoid cerebral herniation. Additionally, ICP monitoring allows for early identification of intracerebral hemorrhage. ICP monitoring is usually indicated for those with GSC ≤5 or GSC <8 with abnormal CT or with other symptoms,

such as posturing or systemic hypotension, that are of concern. ICP monitoring is usually also recommended for children who are unconscious or in shock or exhibit deterioration in neurological functioning.

Studies have been somewhat inconsistent, and some are small, but they generally indicate that ICP <20 mm Hg is rarely associated with death while ICP of 20-40 is associated with up to 28% death rate and 40-60 with almost 100% death rate. Although critical values associated with various physiological variables have not been determined, the goal is usually to maintain the ICP <20.

It's important to remember that in a fluid-filled space, the pressure is usually the same wherever it's checked; however, with brain injury, various interfering factors, such as decreased CSF because of brain swelling, may interfere, so that the pressure obtained by the catheter or sensor may reflect only the pressure at that site rather than pressure within the ventricular system (the site of the most accurate CSF pressure).



ICP can be monitored in a number of different ways, with each method associated with advantages and disadvantages.

According to the **Monroe-Kellie hypothesis**, in order to maintain ICP within normal range, a change in the volume of one compartment

requires compensatory change in the volume of another compartment. The three components are 1) brain tissue, 2) cerebrospinal fluid (CSF), and 3) blood. Since tissue cannot easily accommodate change, medical interventions must focus on blood flow and drainage of CSF.

# **Cerebral perfusion pressure monitoring**

Cerebral perfusion pressure is based on mean arterial pressure (MAP) and intracranial pressure (ICP):

• CPP = MAP - ICP.

Cerebral profusion pressure is the pressure controlling blood flow to the brain and must be maintained within narrow limits as too high results in increased intracranial pressure and too low in ischemia. Cerebral blood flow is usually maintained at a constant and adequate level with a mean arterial pressure between 60 and 150 mm Hg and ICP of about 10.

An increase in mean arterial pressure (MAP) increases the CPP while an increase in ICP lowers the CPP, so monitoring ICP is especially critical. CPP may be decreased by vasospasms associated with the brain injury as well as local pressure from intracranial hemorrhage or concussion.

While studies vary and definitive guidelines have not been established for different pediatric age groups, generally CPP levels should be maintained to at least 60 mm Hg in children (compared to 70-90 in adults). Mortality rates are significant with CPP <40 and survival is high with CPP >40.

# Neuromuscular blocking agents

NMBAs, such as propofol, have been used in some studies to determine if they can reduce ICP and improve outcomes. However, while NMBAs

reduce oxygen consumption by about 10%, the FDA does not recommend the use of NMBAs in pediatric patients with severe brain injury because of the potential for severe adverse effects and inadequate evidence of benefit.

**CSF** decompression

One method of decreasing increased

intracranial pressure is to drain cerebrospinal fluid. This can be done through external ventricular drainage (EVD) per the ventriculostomy or through lumbar drainage or a combination. Lumbar drainage can lead to tonsillar herniation.

CSF drainage is recommended if increased ICP is refractory to other treatments either through EVD by itself or a combination of EVD and lumbar drainage.

# Hyperosmolar solutions

Studies indicate that hypertonic saline solution (HSS) or mannitol are both effective in reducing ICP. Hyperosmolar solutions function to reduce

cerebral edema through osmosis, improving circulation. HSS further expands plasma in order to increase CPP and reduces the hyponatremia that results from brain injury and is one of the causes of increased ICP.

One study showed that mannitol reduced ICP by >10% after 116 boluses, and other studies show benefit of 3% HSS. At present, either mannitol or HSS is recommended as first-line hyperosmolar agent.

Hyperosm	Hypertonic saline solutions has a sodium concentration that exceeds that of NS (0.9%). While concentrations range from 2-23.4%, 3% solutions have been used in most pediatric studies.

	Peripheral lines can only be used for solutions <3%, so solutions with concentrations of ≥3% require central lines HSS is usually given continuously at varying rates (agedependent, at about 5 mL/kg per dose. In the event of severely increased pressure or transtentorial herniation, boluses of higher concentrations may be given over 15 minute periods.		
	Monitoring for hypovolemia is critical as this can increase risk of renal failure. Serum sodium (normal value 145-155 mmol/L) most be monitored every 6 hours and serum osmolality (normal value 320 mOsmol/L) every 12 hours.		
Mannitol	Mannitol, an osmotic diuretic, decreases ICP and reduces cerebral edema by increasing sodium and fluid excretion. Mannitol 15% to 25% solution is given per intravenous infusion at 0.25 to 2 g/kg, depending on age, over 30-60		

minutes—usually resulting in decreased ICP within about a quarter of an hour.

Mannitol must be handled carefully according to manufacturer's guidelines as crystals can form in the solution if it is too cold. Mannitol is usually heated to 80°C, shaken to dissolve crystals, and then cooled to body temperature prior to administration. Polyvinylchloride containers must be avoided as they cause precipitates to form. Filters must be used with concentrations of 20-25%.

Fluid and electrolyte balances must be carefully monitored.

### Hyperventilation

Hyperventilation can be used to decrease ICP by inducing cerebral vasoconstriction, which results in decreased cerebral blood flow. However, hyperventilation can cause respiratory alkalosis, which result in a left shift in the hemoglobin-oxygen dissociation curve with decreased oxygen to tissues and ischemia. One study showed that hypocarbia resulting from hyperventilation increased cerebral ischemia from 28.9% to 73.1%. Therefore, the recommended use of hyperventilation is restricted to brief periods to treat cerebral herniation or acute deterioration of neurological status if other treatments fail.

# Barbiturate-induced coma

Barbiturates, primarily high doses of pentobarbital, can reduce ICP by reducing cerebral blood flow and cerebral blood volume and may be used as adjunctive

therapy early in treatment or as part of treatment for refractory ICP. However, the use of barbiturates is associated with hypotension and myocardial depression and requires invasive hemodynamic monitoring. Barbiturates may be recommended for children who are hemodynamically stable and have refractory ICP.

### Hypothermia

A number of studies have looked at the benefits of hypothermia to reduce ICP, but there is currently no specific recommendation for use in pediatric brain injury.

# **Decompressive** craniectomy

Studies indicate that decompressive craniectomy improves survival and neurological outcomes in those with severe brain injury and refractory ICP, especially in younger patients. This, along with

barbiturate-induced coma, is a second tier therapy. A bifrontal craniectomy is most common, with studies showing this procedure resolved refractory increased ICP in about 44%.

Decompression is indicated for rapidly expanding epidural or subdural hematoma. Subdural hematoma associated with midline shift or altered mental status requires emergency drainage although smaller hematomas with no midline shift or indications of increasing pressure may be managed conservatively.

Depressed skull fractures must be elevated surgically if they depress >1 cm, if the depression is thicker than the calvaria (skull cap), or if fragments are resulting in compression of brain tissue.

Complications can include brain shift from over drainage of CSF and bone resorption up to 50%. Additionally, bone flap storage for children can pose challenges.

#### Corticosteroids

Corticosteroids have been used for a wide range of neurological disorders and reduce cerebral edema; however, they increase risk of infection and gastrointestinal bleeding, and studies show corticosteroids do not make a difference in outcomes. Therefore, they are not recommended for use with pediatric brain injuries.

#### **Anticonvulsants**

Anticonvulsants have been used both to treat post-traumatic seizures (PTS) and as prophylaxis to prevent them. Studies have varied in

outcomes with some showing reduction in early PTS and improved survival rates and others showing no reduction in late PTS. Current recommendations are that anticonvulsants are not recommended as prophylaxis to prevent late PTS in pediatric patients. However, if seizures are present (as may be the case with severe injury), initial treatment is usually with a short-acting benzodiazepine, such as lorazepam or diazepam, followed by maintenance with phenytoin or phenobarbitol.

#### **Positioning**

There is no consensus regarding positioning, but elevating the head to 30-45° may show a small improvement in ICP; however, elevation must be avoided with hypotension, and some ICP monitoring may be affected. Many authorities recommend elevating the head to 30° and maintaining the head in midline position to increase venous drainage and decrease the ICP without impairing cerebral blood flow.

### **Protocol example**

While protocols may vary somewhat, that outlined by *Critical Care Medicine* is fairly standard:

- CT is indicated with GS ≤8 or with lesion, diffuse or focal swelling.
- Insertion of EVD or ICP monitor.
- First tier interventions:
  - CSF diversion; EVD at 0-3 cm above tragus.
  - Sedation and/or paralysis.
  - Elevate HOB to 30°,
  - Maintain paCO2 at 35-38 m hg.
  - o Maintain O2 saturation ≥92%
- If inadequate response from first tier intervention, repeat CT.
- Second tier interventions:
  - Mild hyperventilation (paCO2 30-35 mm Hg).
  - Mannitol (0.25-1.0 g/kg IV q 4-6 hours) with serum osmolarity <320.</li>
  - HSS 3% boluses or slow infusion with serum osmolarity <370.</li>
  - Low dose barbiturates (5 mg/kg/IV q 6 hrs.) with escalation to burst suppressed, barbiturate coma).
- If no response to second tier interventions, repeat CT.
- Third tier interventions:
  - Decompressive craniectomy or temporal lobectomy.
  - Moderate hypothermia (32-33°C).
  - Transient hyperventilation to PaCO1 < 30 mm Hg)</li>

### Glasgow coma scale and AVPU

The **Glasgow coma scale** (GCS) is a measure of the depth and duration of coma or impaired level of consciousness and is used for postoperative and neurological injury assessment. The GCS measures best eye response, best verbal response, and best motor response. The same scale used for older children and adults is used with slight modifications (indicated in parentheses) for infants and young children ( $\leq 5$ ).

The total possible scores range from 3 to 15, with lower scores indicating increasing morbidity. Injuries and/or conditions are classified according to the total score:

- 3-8 Coma
- ≤ 8 Severe head injury
- 9-12 Moderate head injury
- 13-15 Mild head injury.

### **AVPU**

The AVPU assessment is a quick assessment done to determine the patient's level of consciousness:

Those who are not responding to painful stimuli (P) usually have an equivalent score of about 8 on the GSC, consistent with severe injury.

### Injuries consistent with accidental falls

While children can develop serious head injuries from falls, the vast majority of accidental falls do not cause serious head trauma, so almost any child presenting with severe injuries or multiple injuries related to a fall should be examined further for evidence of abuse:

- **Falls from bed** (2-4 feet): Injuries are usually minor although a small number may have a skull or other fracture, such as a clavicle. Severe head trauma is rare and should be suspect. The degree of injury may depend on the type of flooring, as carpeting is associated with lower levels of injury.
- Falls from walkers: Most injuries result from falling down stairs in the walker rather than out of the walker onto the floor although falling onto a concrete floor increases risk. Studies show about 1-8% may develop intracranial bleeds.
- Falls down stairs: Injuries are less severe in free falls than if someone was holding and dropped the child down the stairs.
   Single injuries to the head or extremities predominate when children fall down stairs. Multiple injuries are not common, and stairway injuries are generally less severe than other free falls of the same total distance.
- Falls from various heights: Short vertical falls (≤4 feet) rarely cause severe head trauma or multiple injuries unless associated with abuse. One study of deaths in children related to minor falls found that those who died after a fall of 1-4 feet had evidence of other injuries consistent with abuse. Another study looked at

children who died after falls of 5-6 feet and found that 74% had evidence of abuse.

Even falls from 10 feet or higher rarely result in death unless the height is extreme, such as from a 2<sup>nd</sup> or 3<sup>rd</sup> floor. The greater the height is, the greater the incidence of skull or other fractures. A study of 75,000 cases from the US Consumer Product Safety Commission found that only 18 suffered fall-related injury deaths over 11 years, with 7 falling from swing and 11 from a horizontal surface, such as a ladder.

### Conclusion

Healthcare providers often have ethical concerns about the legal and social implications of a diagnosis of abusive head trauma, but healthcare providers are legally and morally required to report suspected abuse to child protective services. Because of this, taking time to do a complete assessment to rule out differential diagnoses is critical—and necessary should abuse result in legal action against the caregiver.

Early identification of abusive head trauma is especially important. One retrospective study of 5 cases of death associated with abusive head trauma but with delayed diagnosis showed that 4 out of the 5 may have survived with earlier intervention. While infants <2 are most often victims of abusive head trauma and most often exhibit the classic signs associated with shaken baby syndrome, one study of older children (2-7) showed that they exhibited very similar symptoms with acute subdural hematoma, bilateral retinal hemorrhages, and diffuse axonal injury.

A chilling recent study (2021, April) shows cases of abusive head trauma during the recent recession increased to twice the usual number, suggesting that the stress of dealing with the recession has triggered increased violence toward children.
